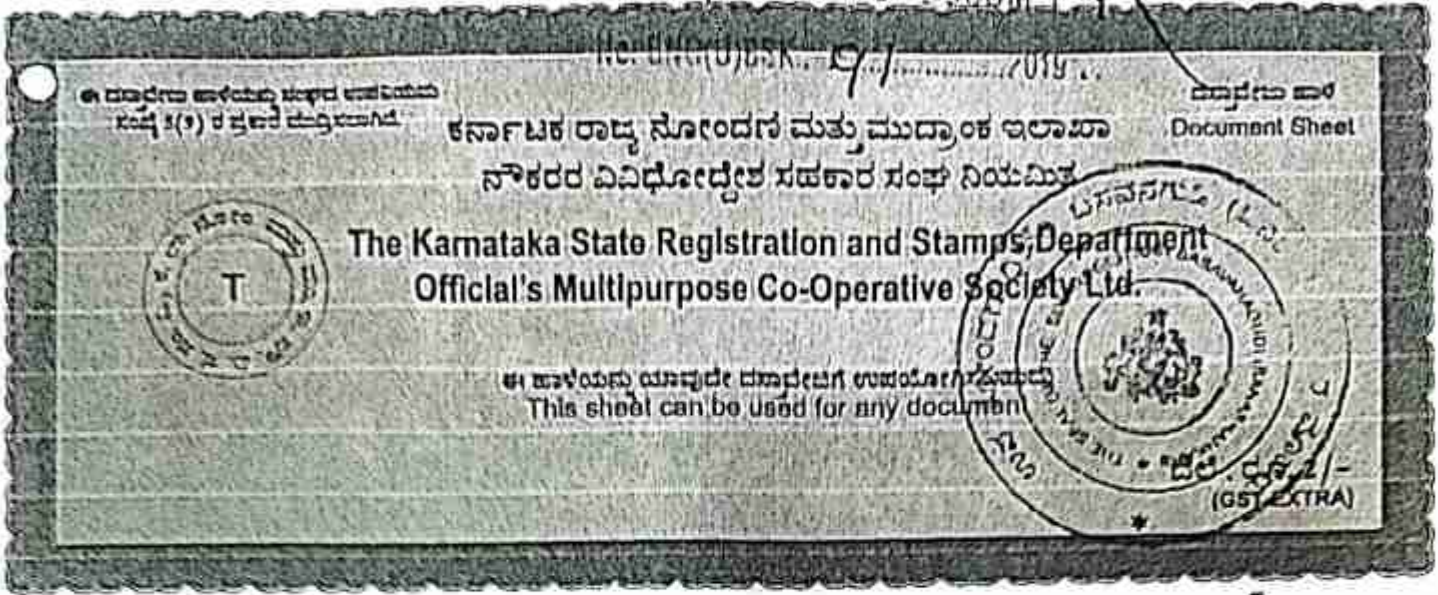

- R. To Collaborate/ enter into agreement with foreign schools, colleges, educations intuitions to offer their courses/conduct examinations/ collect appropriate fees/ issue certificates and vice versa.
- S. To establish, run and maintain one more universities under any state or central legislation of India and provide instructions, teaching and training, research and development in various disciplines and make provisions for advancement

4. The trust hereby declared is irrevocable the Author of the Trust hereby declared is irrevocable of the Trust hereby expressly further declares that he neither reserves any rights to revoke trust nor any benefit either directly or indirectly for the trust under any circumstances.

5. TRUSTEES AND THEIR OTHER CONSTITUTIONS:

- A. The AUTHOR of the TRUST does hereby constitute, nominate and appoint the parties of the SECOND PART as the FIRST TRUSTEES for the PERMANENT TRUSTEES or BOARD of the trustees of the trust. The TRUSTEES hereby appointed shall hold office as TRUSTEES.
- B. The TRUSTEES may if necessary appoint any one or more of their body to the office of the Treasurer or PRESIDENT/FOUNDER TRUSTEE of the TRUST and entrust them with such rights and powers in relation to the conduct of the TRUST and its affairs as needed.
- C. All the TRUSTEES, who are for long time being, and from time to time, in office shall constitute and referred to collectively as the BOARD OF TRUSTEES' or the 'BOARD'.
- D. The author of the trust, who is also a trustee as here in above mentioned shall be the PRESIDENT/FOUNDER TRUSTEE for life or until he resigns.

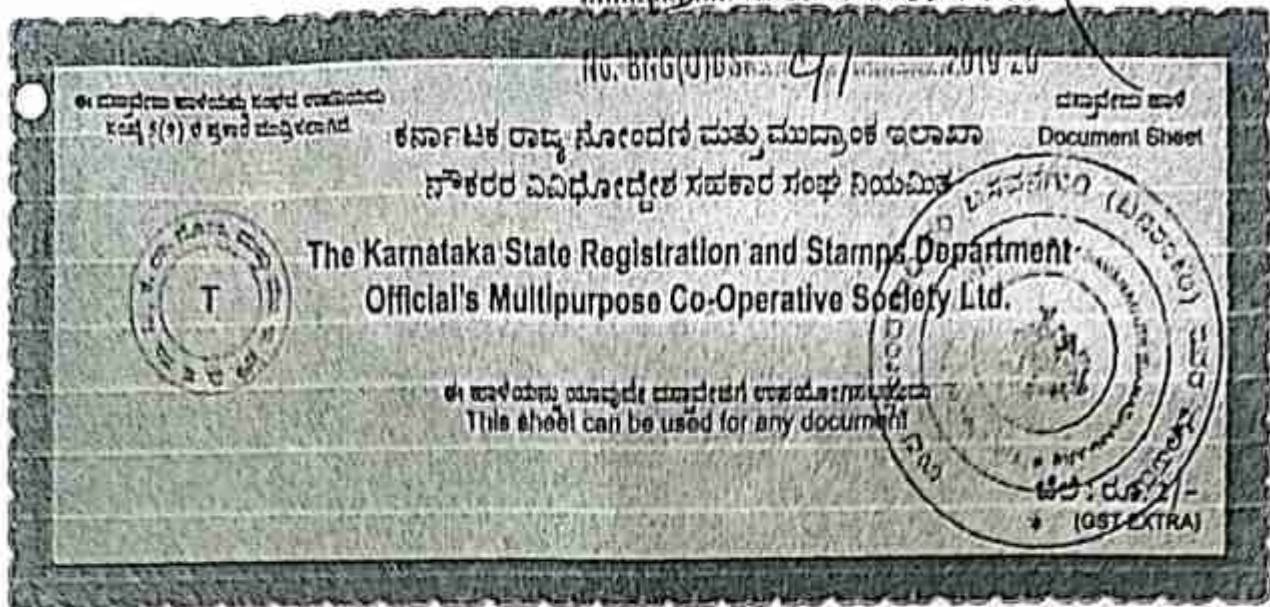
- H. The administration, direction, and management of the properties of the TRUST and of the institution and establishment maintained or run by the TRUST hereby created shall subject to the supervision, control and direction of the Board, be with the PRESIDENT/FOUNDER TRUSTEE.
- I. The funds of the properties of the TRUST shall be initially the said sum of Rs.10,001/- (Rupees Ten Thousand And One Only) (vested with the TRUSTEES as stated supra) and all and every other properties (including a right in or to any business undertaken or share therein) gifted, conveyed and transferred to the Trust hereby created and all or any income derived from the said sum, moneys and properties and the addition accretion and augmentation thereto and the investment thereof as set out infra.
- J. The TRUSTEES shall have power to augment the funds of the TRUST from any source what over by accepting gifts of land, building voluntary contributions monetary or otherwise and any kind of help, if the opinion of the TRUSTEES such acceptance will be in the interest of the TRUST.
- K. - M. The PRESIDENT/FOUNDER TRUSTEE of the BOARD OF TRUSTEES may convene the meeting of the BOARD OF TRUSTEES by serving notices of the meeting to the other members of the BOARD OF TRUSTEES in writing/by email, and setting out there in the matter to be discussed and the place of the meeting, the day, date and time of the meeting.
- N. The office of the TRUSTEES or the members of the BOARD OF TRUSTEES as the case may be, shall be honorary and any person holding such office shall not be entitled to draw any remuneration for carrying out their duties, but shall be entitled to be paid their actual traveling expenses and other incidental charges incurred by them for attending to the work of the TRUST. However if any TRUSTEES does any work of teaching which otherwise would have been done by any other such TRUSTEES. may be paid remuneration which shall be approved by the PRESIDENT/FOUNDER TRUSTEE.
- O. 6. POWERS OF THE BOARD OF TRUSTEES:
